City Bus Driver Update

Over the last 3 weeks the City has been able to staff a minimum of 35 drivers by offering the following benefits/incentives:

- Increased pay
- Increase bonus of \$1250 (contingent on staying accident free)
- Ski passes

WINTER PARKING RESTRICTIONS

Parking problems are compounded by winter snow, which accumulates fast with each storm. In order to expedite snow removal efforts, parking is prohibited on City streets and shoulders during the following hours from November 1 through April 30.

Location	Restricted Hours
Lincoln Avenue:	3 a.m. to 6 a.m.
Ski Time Square:	3 a.m. to 6 a.m.
Anglers Drive area and south to city limits:	Midnight to 8 a.m.
All Other Areas:	2 a.m. to 8 a.m.

Your vehicle may be ticketed if left on City streets within the restricted hours or towed during snowplow operations within the restricted hours.
