This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of March 2010, which were remitted to the City in April 2010.

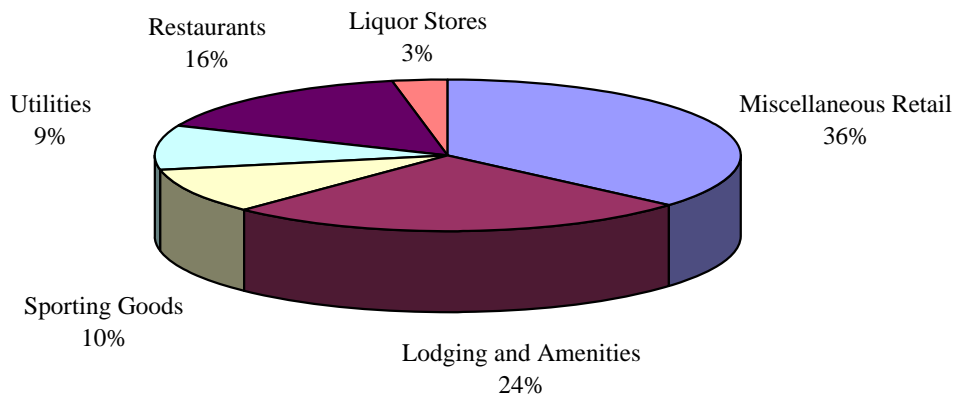
Sales Tax

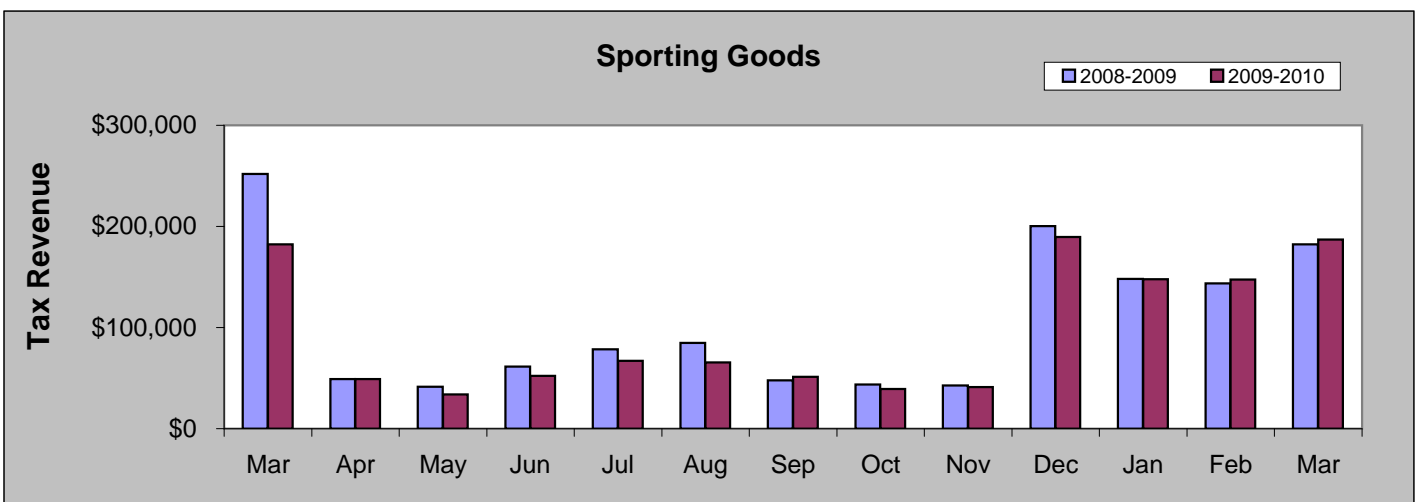

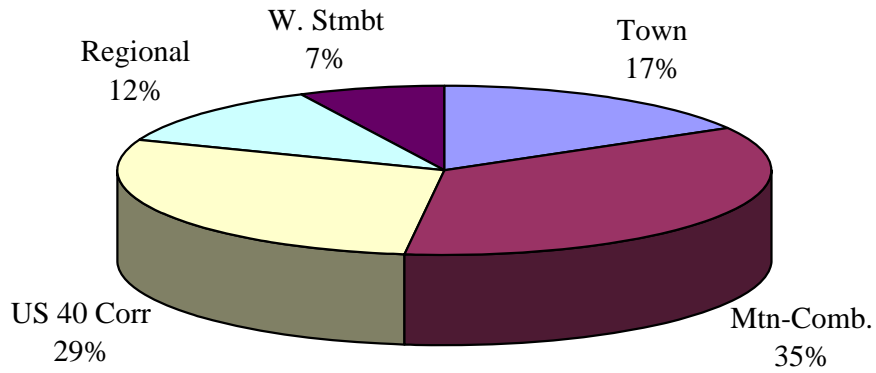

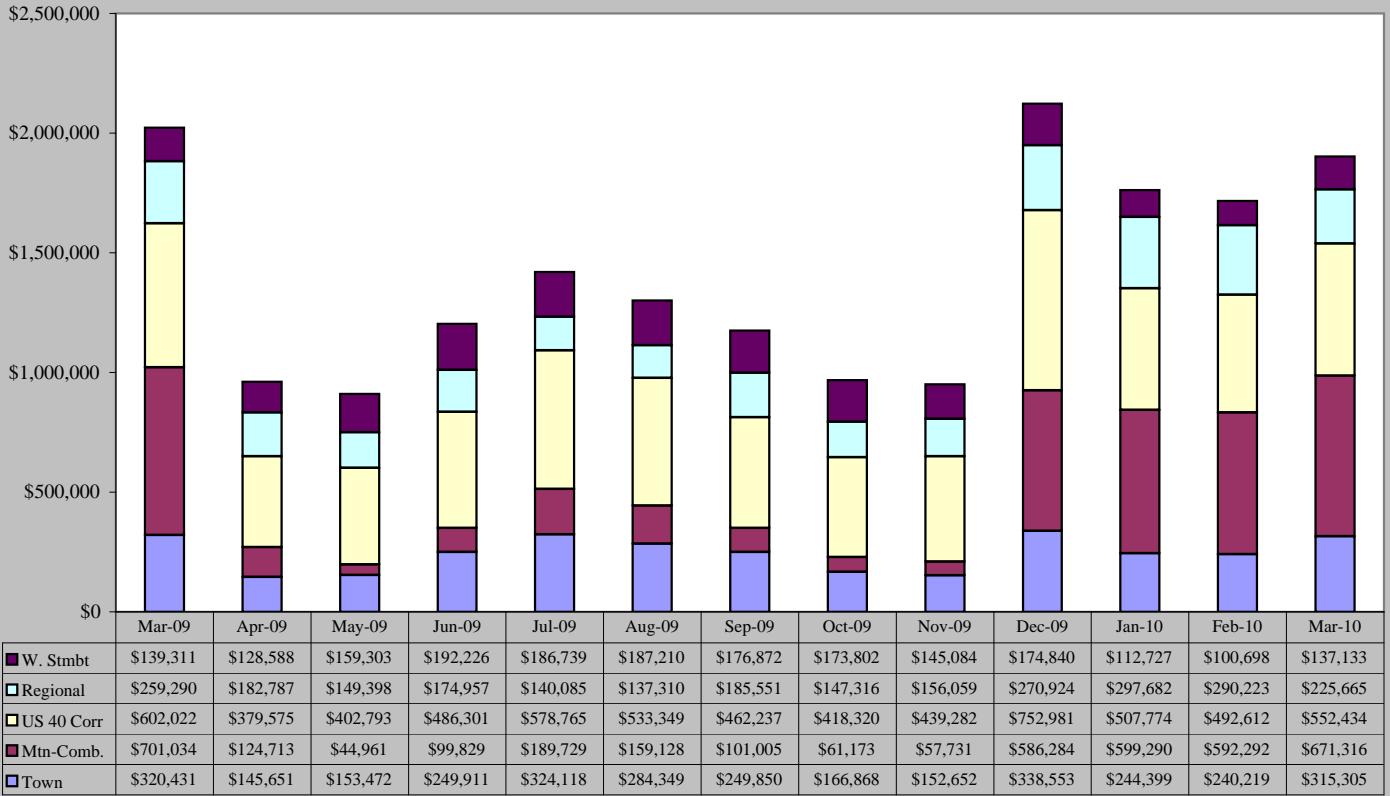

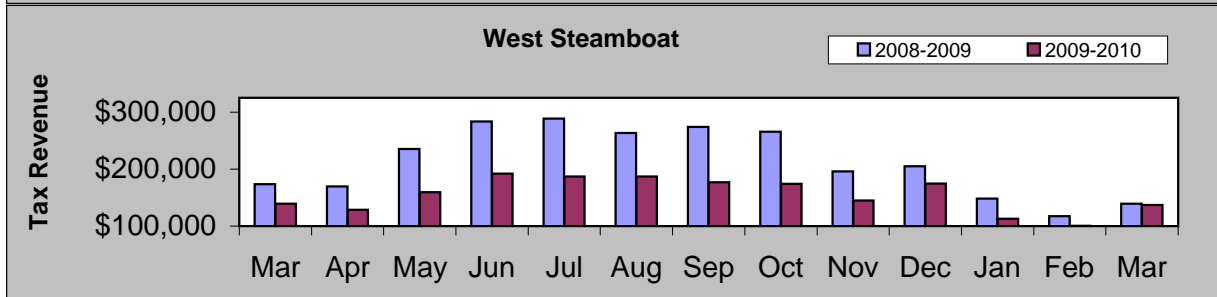

Building Use Tax

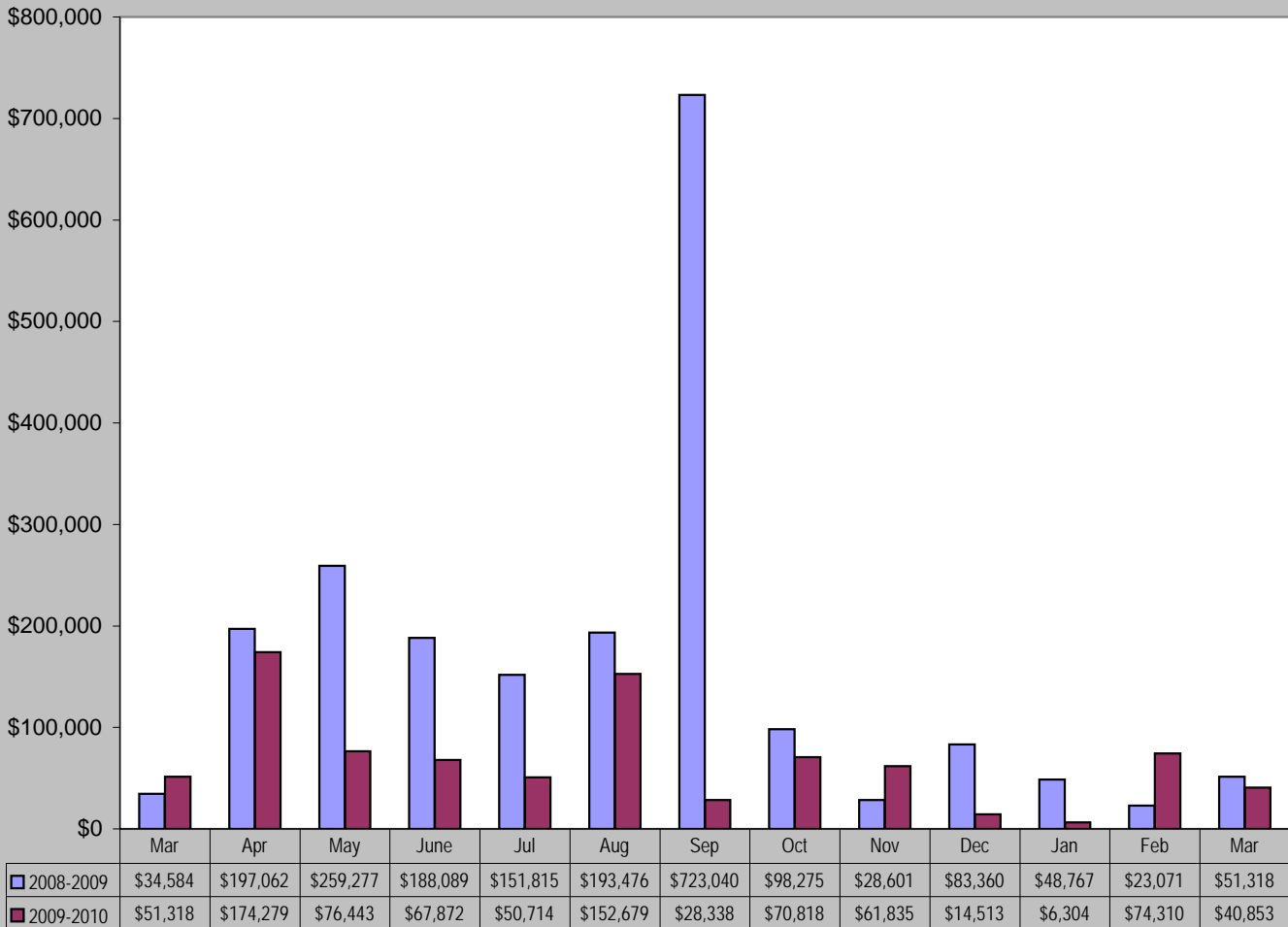
March 2010 Building Use Tax collections decreased 20.39% from March 2009.
