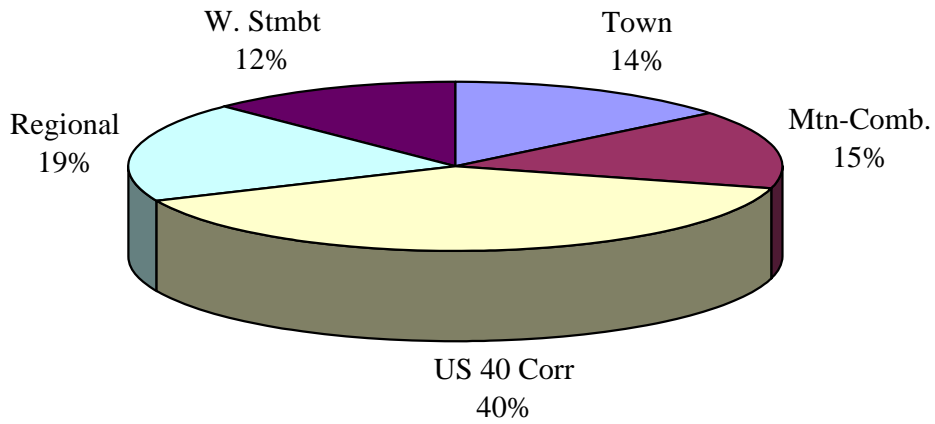

# Building Use Tax

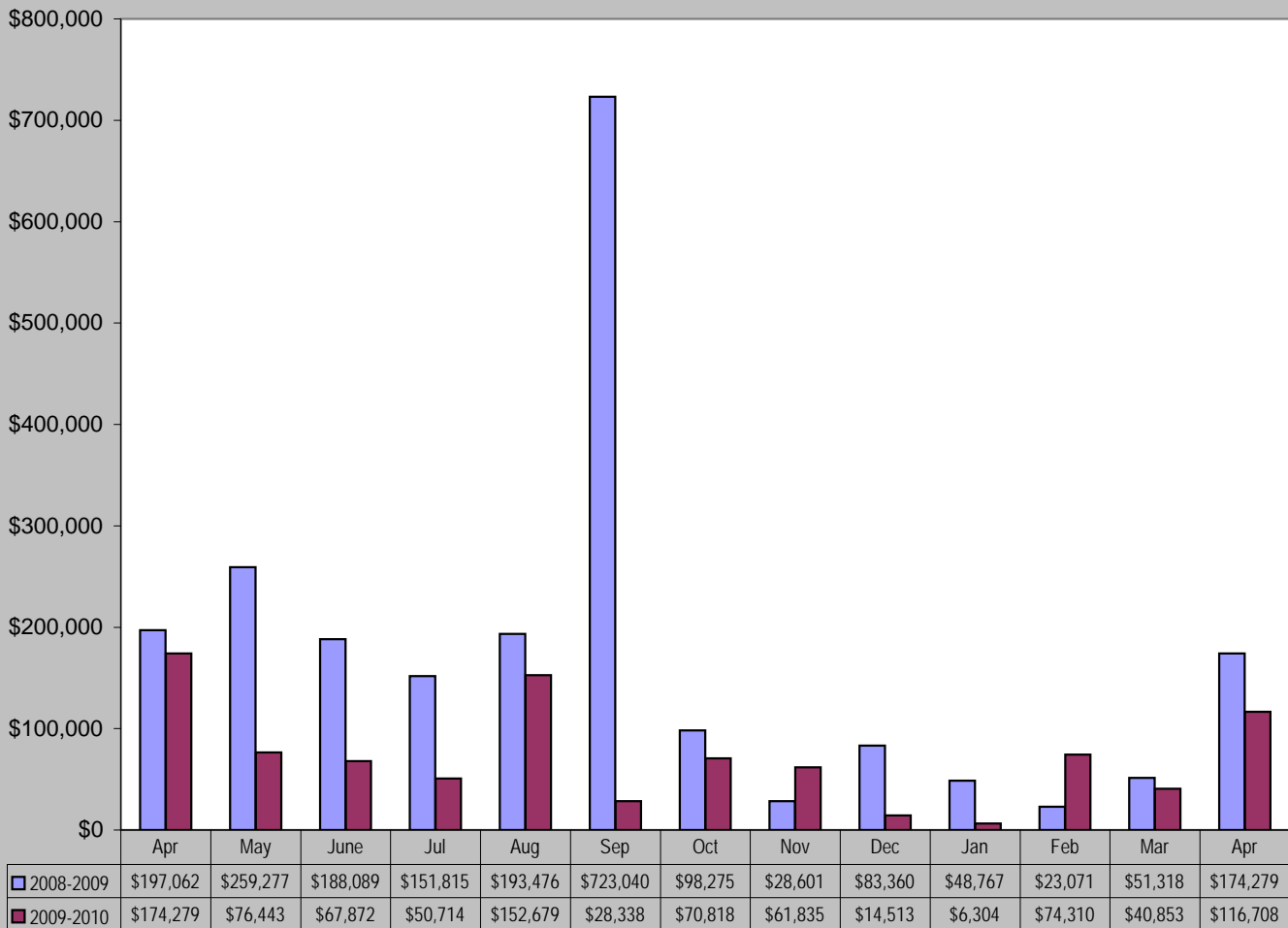
April 2010 Building Use Tax collections decreased 33.03% from April 2009.
