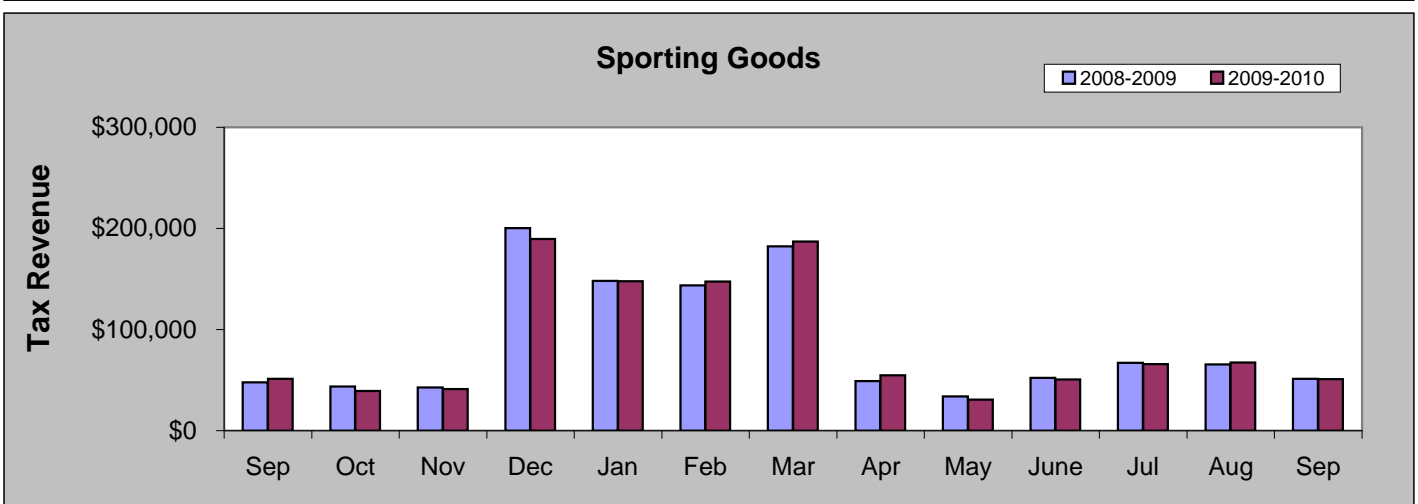

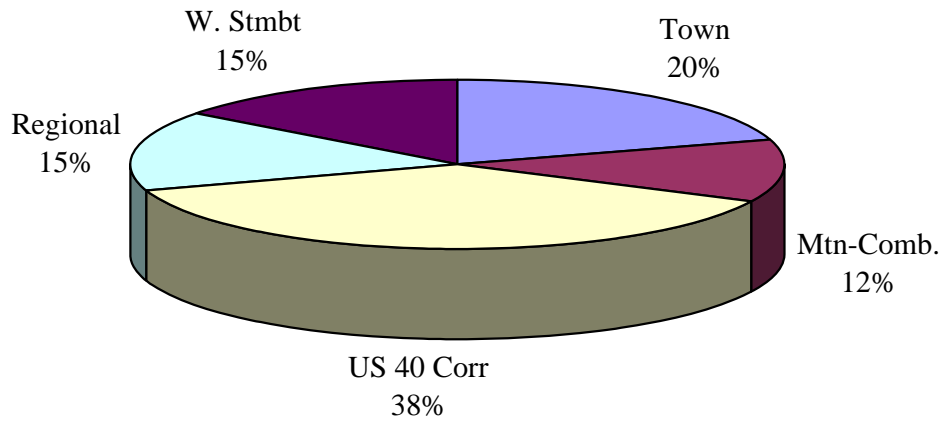

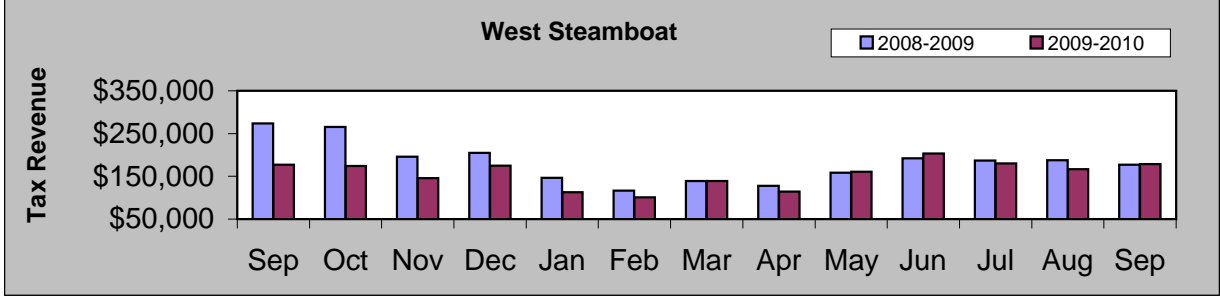

Building Use Tax

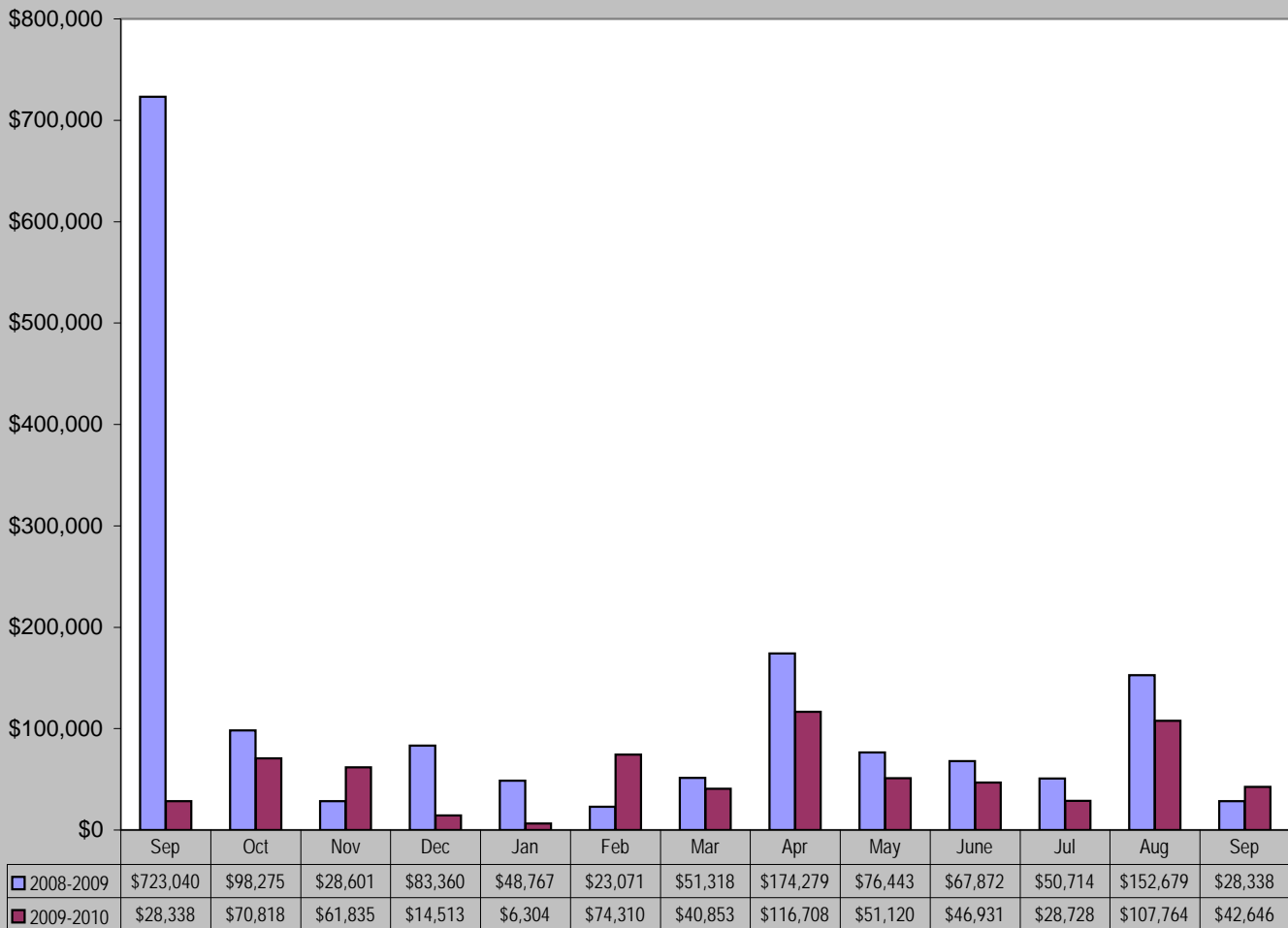
September 2010 Building Use Tax collections increased 50.49% from September 2009.
