3. If the business is in violation of section 12-100 through 12-108 and section 12-200 through 211 of the Municipal Code of the City of Steamboat Springs the applicant may be fined up to \$500 and his or her license may be suspended or revoked. _____
4. The applicant is responsible to instruct his or her employees that selling tobacco products to a min is against the law. _____
5. Any employee selling tobacco products to a minor may cause the business to be fined, license suspended, or revoked due to a violation under the laws of the City of Steamboat Springs, the State of Colorado, or the United States. _____
6. The business will be subject to inspection for compliance with section 12-100 through 12-108 and section 12-200 through 211 of the Municipal Code of the City of Steamboat Springs and may involve the use of minors under the supervision of law enforcement to ensure that the applicant's business is not selling tobacco to minors. _____

READ CAREFULLY BEFORE SIGNING: Under penalty provided by law, the applicant states that each of the above questions has been truthfully answered to the best of the knowledge of the applicant. Applicant agrees to operate this business according to the law and that the rights and responsibilities conferred to the license, if granted, cannot be assigned to another. Any lack of access to any portion of a licensed premise during inspection will be deemed a refusal to permit inspection. Such refusal is grounds for revocation of this license.
