









# Free Call4All Legal Clinic Expands to Northwest Colorado

**STEAMBOAT SPRINGS, COLORADO-January 12, 2018-**Colorado Legal Services is expanding its free, phone-based Call4All Legal Clinic to Grand, Moffat, Routt and Rio Blanco Counties beginning on January 17, 2018.

The Call4All program provides free one-on-one legal conversations with attorneys to assist low-income community members that do not have attorneys. The free call-in clinic occurs on the third Wednesday of every month, from 5pm to 8pm.

Volunteer attorneys can answer civil legal questions, assist with court forms and explain the law and procedure for the following legal topics: family law, landlord/tenant law, protection orders, consumer/collections and small claims.

Individuals may call toll-free, 844-404-7400, between 5pm to 8pm on January 17, February 21, March 21, April 18, May 16, June 20, July 18, August 15 and September 19, 2018. Please remember that the clinic telephone line is only answered during clinic hours.
