This City of Steamboat Springs Sales, Use, and Accommodation Tax Report examines tax collections for the month of July 2020, which were remitted to the City in August 2020.

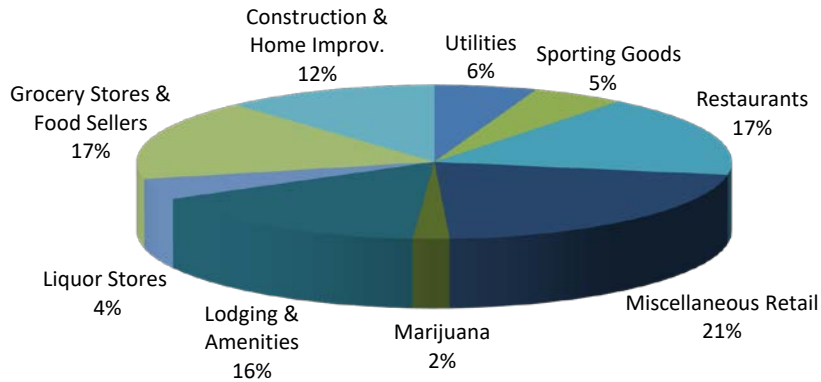
Sales Tax

Year-to-date total sales tax collections are 6.56% lower than those of 2019 year-to-date.

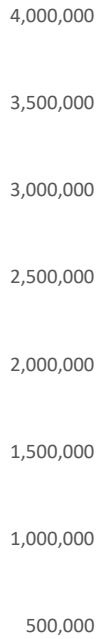

July 2020 Sales Tax By Area



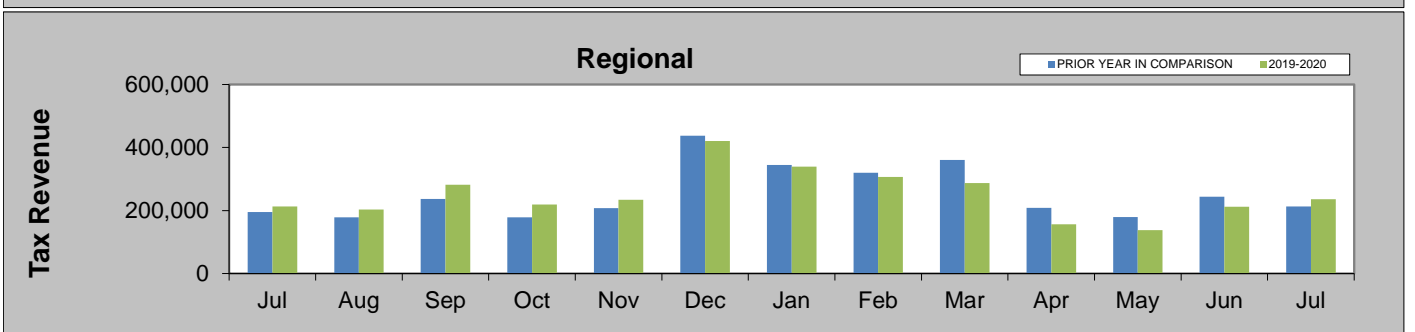
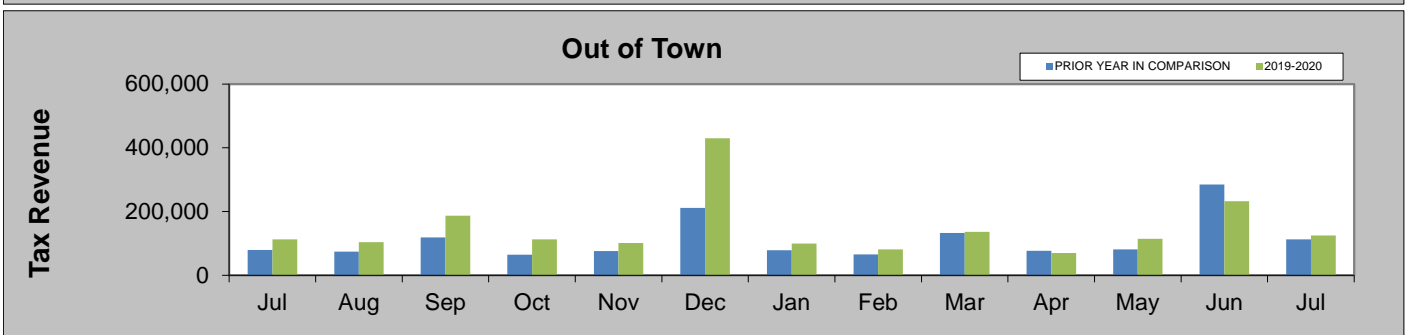
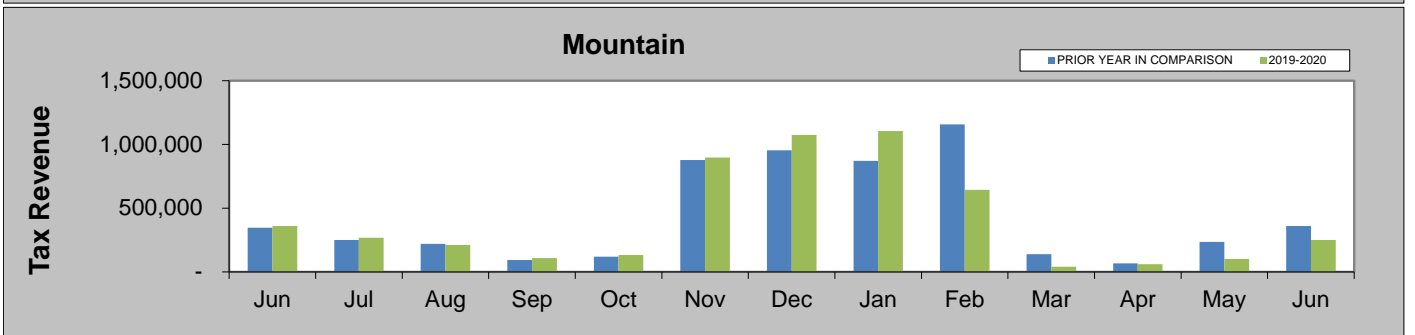
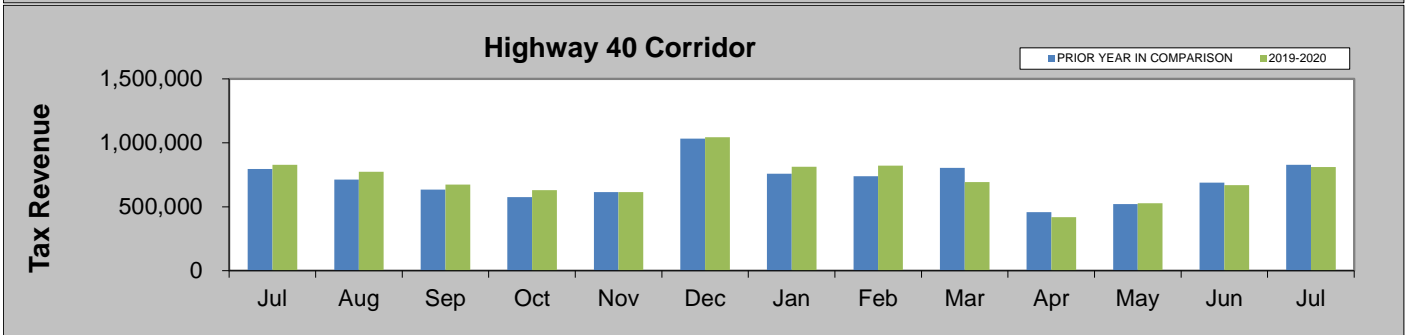
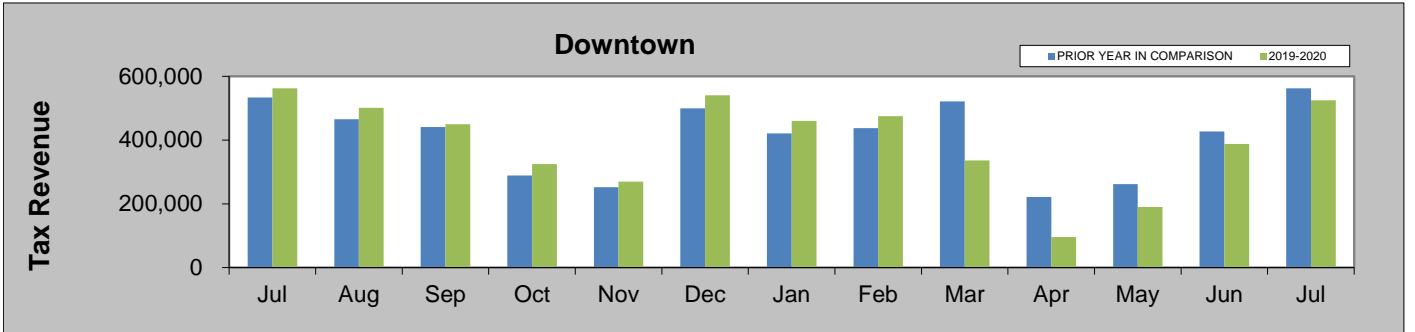

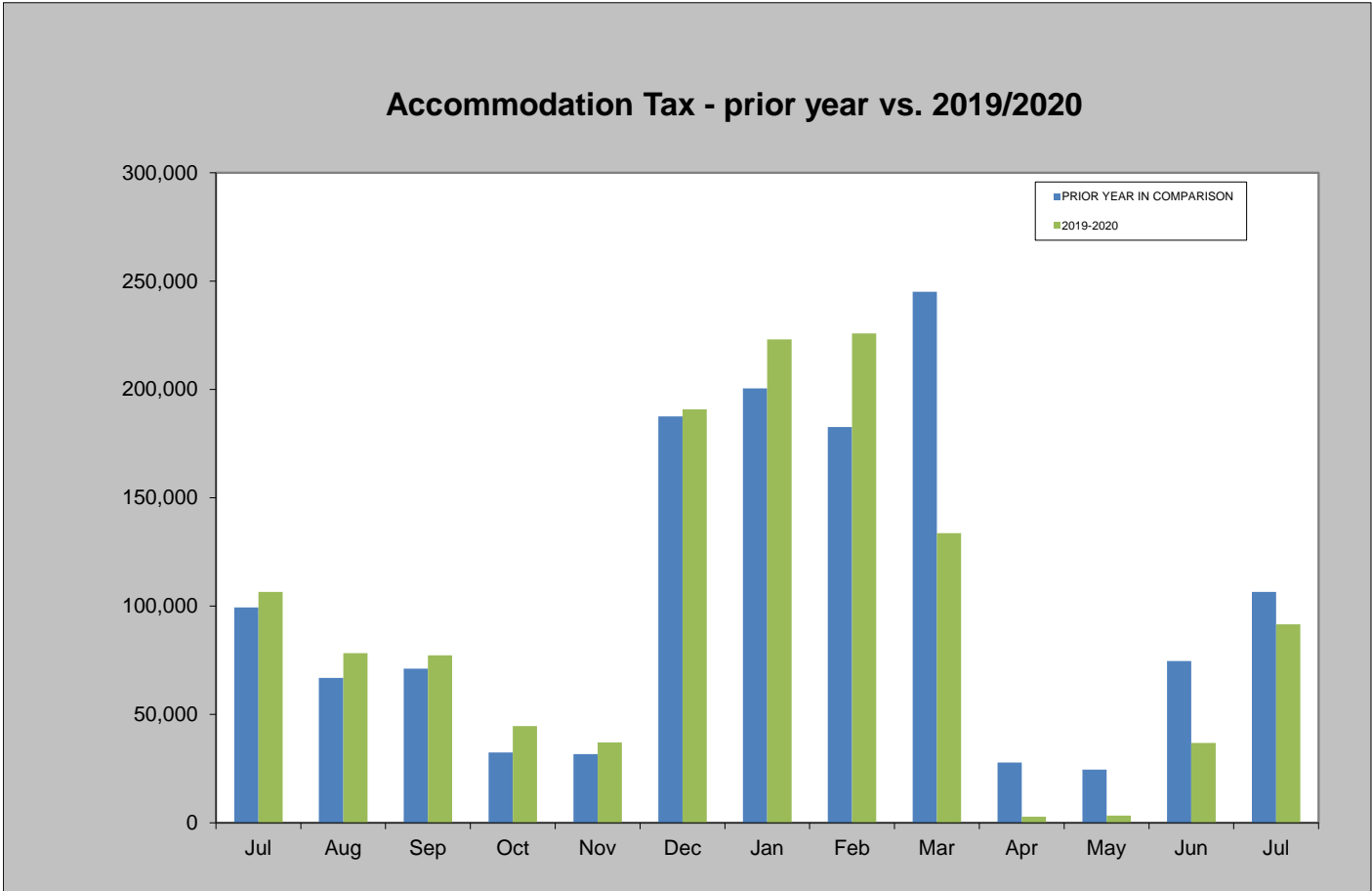
Accommodation Tax

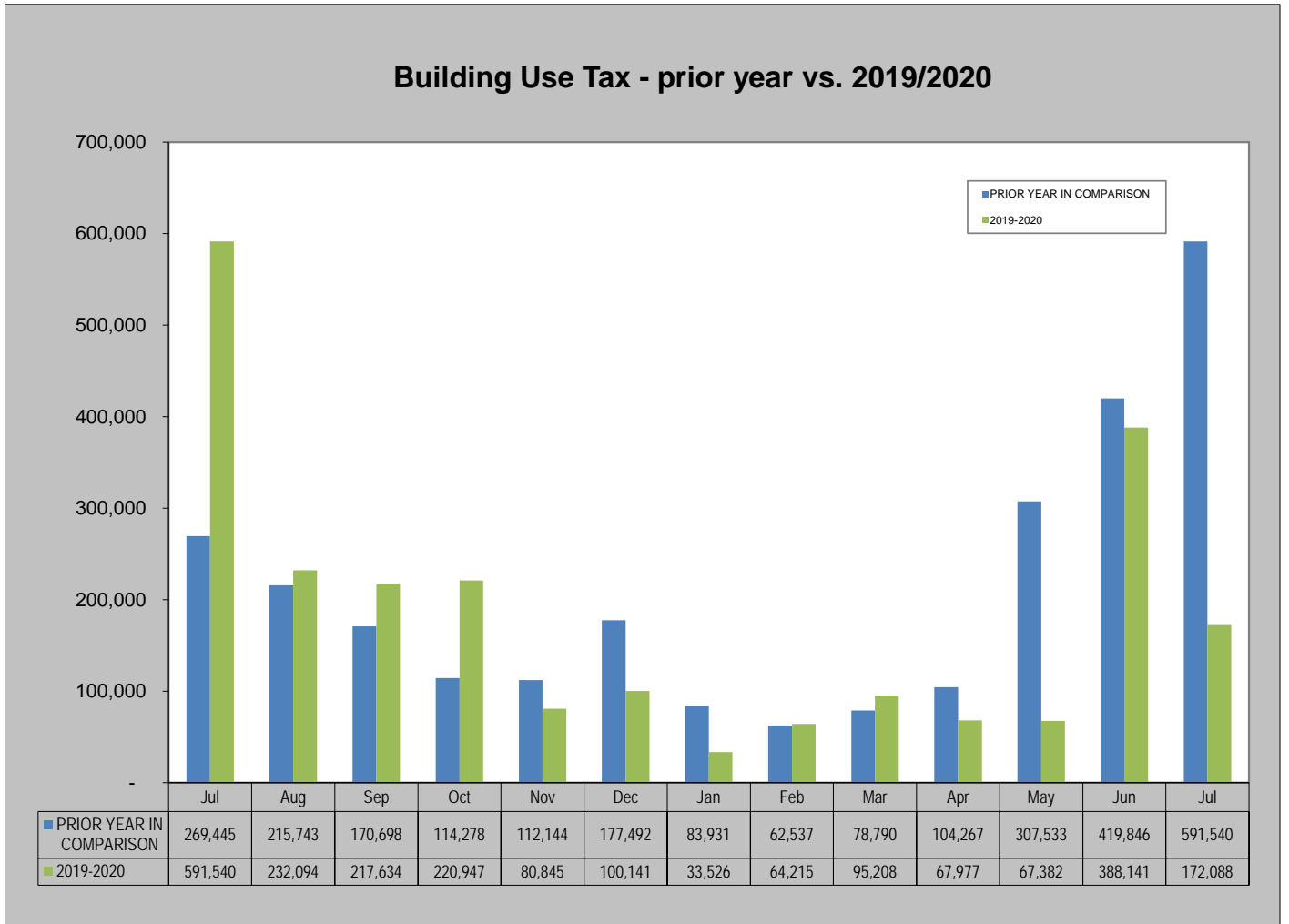


Building Use Tax

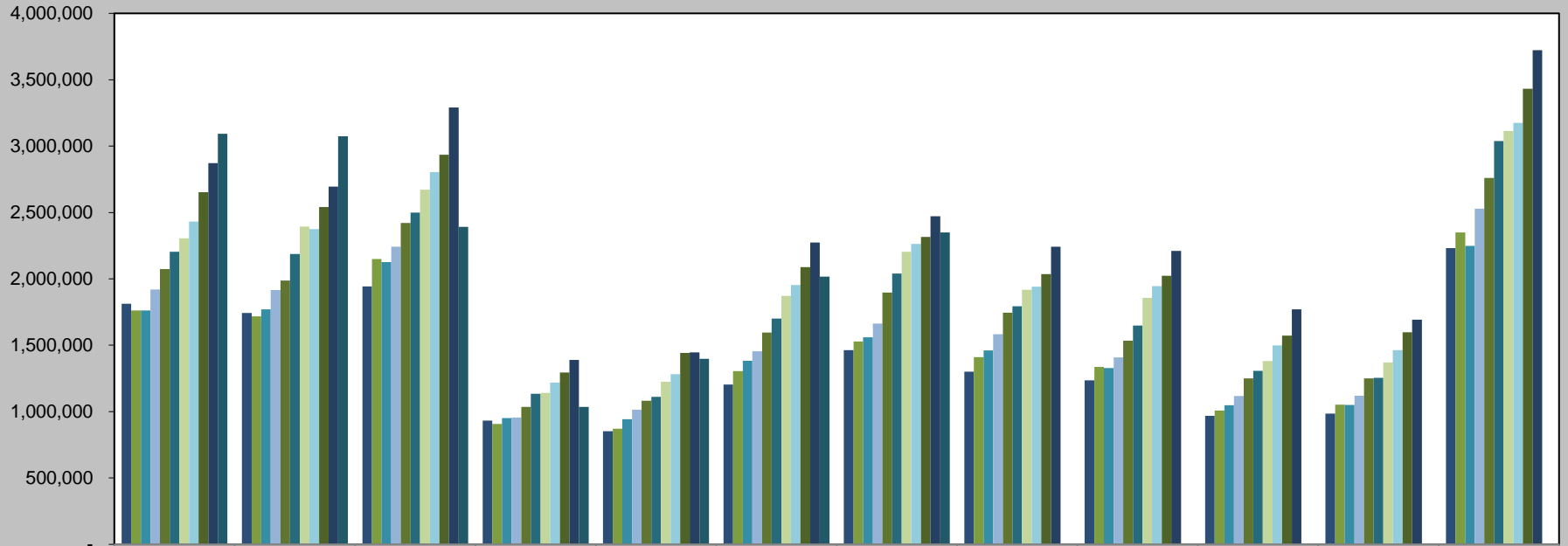
July 2020 building use tax collections decreased by 71% compared to July 2019.

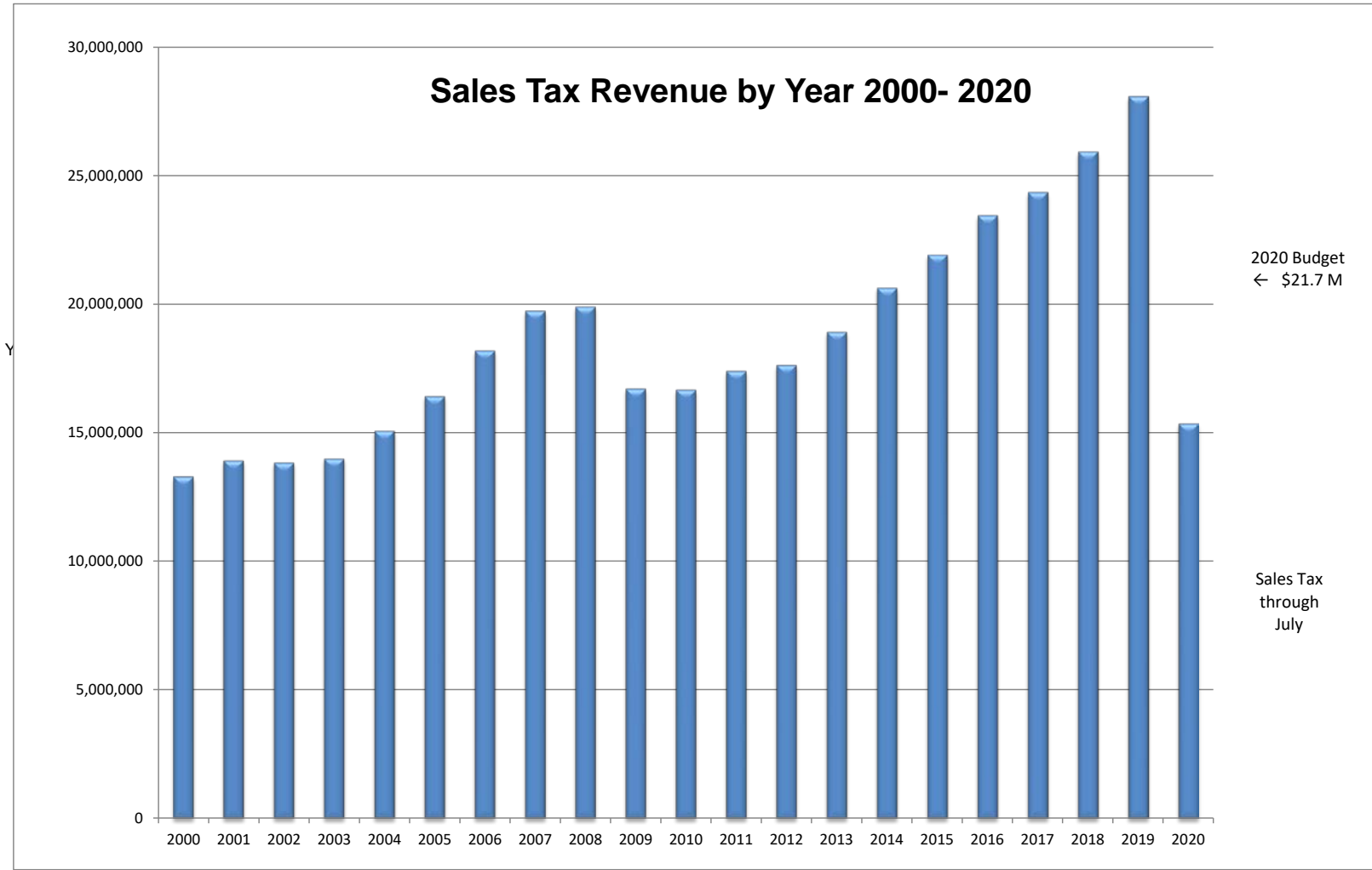
