

QUICK GUIDE: STR Overlay Zone and Licensing

Can I use my property as a STR? What approvals do I need for a STR?

Short-Term Rental (STR) is a dwelling unit offered, provided, used, or operated as a lodging accommodation to guests in exchange for remuneration or other consideration for a period of less than 30 consecutive days while the owner or other permanent resident does not reside in the dwelling unit.

Hosted Short-Term Rental (Hosted STR) is the use of one guestroom (maximum 400 square feet) located within a dwelling unit offered, provided, used, or operated as a lodging accommodation to guests in exchange for remuneration or other consideration for a period of less than 30 consecutive days while the owner or other permanent resident is residing and present in the dwelling unit.

Temporary Short-Term Rental (Temporary STR) is a primary residence that is offered, provided, used, or operated on a temporary and limited basis as a lodging accommodation to guests in exchange for remuneration or other consideration for a period of less than 30 consecutive days while the owner or other permanent resident is not present in the dwelling unit.

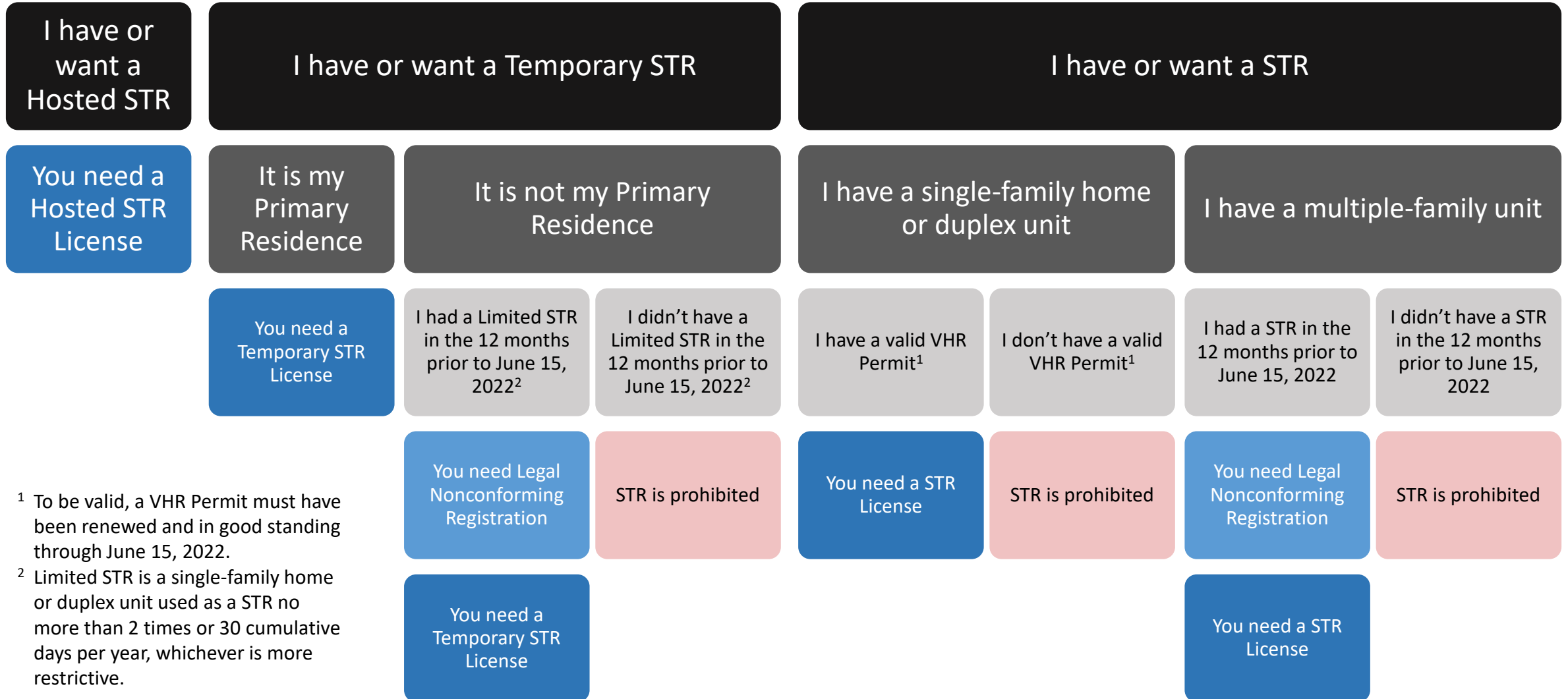
